1. LOCATION OF SYSTEM UNDER WARRANTY

This is to certify that the MEGAnet® system from MEGAsystems installed at THE SYSTEM OWNER'S ADDRESS (hereinafter referred to as "The Customer") is covered under the terms and conditions of this warranty for every product and channel installed and satisfactorily tested according to the international and local standards outlined in Clause 6 herein below.

2. LIFETIME OF SYSTEM AND DURATION OF WARRANTY

The lifetime of the MEGAnet® system will not exceed the following time period from the date of commencement of this agreement as stated hereinabove:

- MEGAnet Cs Copper products 25 years
- MEGAnet Cs Fibre products 25 years
- MEGAnet Cs Enclosures products 1 year
- MEGAnet Active Equipment products 1 year

The warranty for each of these products or subsystems will therefore cease after the abovementioned time periods.

3. VALIDITY OF WARRANTY

This warranty will only be deemed valid if:

- All system components used are MEGAnet Cs products from MEGAsystems
- All MEGAnet Cs products are purchased from an authorised MEGAnet® distributor
- All MEGAnet Cs products have been installed by an authorised MEGAnet® installer
- New MEGAnet® products were used at the time of installation
- No damage has occurred to the MEGAnet® system or products due to: man-made or natural disasters, acts of God, power surges or faults, faults with the building or building systems, or negligent use or handling by any person or an accident beyond MEGAsystems' control after delivery to the authorised MEGAnet® distributor's carrier

4. ALTERATIONS, REPAIRS, OR ADDITIONS

This warranty does not cover any part of the MEGAnet® system installation that has been altered, repaired, modified, or extended after the commencement date of this agreement stated herein above.

A new warranty application must be submitted for any alterations, repairs, or additions to the MEGAnet® system, which must only be performed by an authorised MEGAnet® installer.

5. PRODUCT GUARANTEE

MEGAsystems warrant that the MEGAnet® products installed in the location specified in clause 1 are free of defects in materials, workmanship, and design.

6. PERFORMANCE GUARANTEE

WIRESPEED PRODUCTS

7. CLAIM PROCEDURE

The Customer must submit a written MEGAwarranty Claim Application Form to MEGAsystems for any alleged defect in the MEGAnet® system, which is covered under this warranty, within seven days of the discovery and before the expiration of the warranty period stated in clause 2 hereinabove.

Claim applications will only be deemed valid if:

- A MEGAwarranty Claim Application Form is submitted to MEGAsystems as stipulated in clause 7.1 above
- All system documentation including blueprints, installation records, test reports are submitted to MEGAsystems immediately on request by MEGAsystems
- MEGAsystems or a designated representative is given access to the site to inspect the alleged defect

In the event of a dispute relating to any claim submitted by the Customer under the provisions hereinabove, the Customer must provide proof to MEGAsystems that the conditions set out in clause 3 hereinabove have been complied with in full.

8. LIABILITY

Any compensation made under this warranty is at the discretion of MEGAsystems. MEGAsystems' liability is only to the Customer and only at the location stipulated in clause 1 hereinabove. Should there be a change of ownership of the MEGAnet® system, it would be to the discretion of MEGAsystems to extend the MEGAwarranty to the new owner. The new owner must apply for the transfer of ownership in writing to MEGAsystems within seven days of purchasing the MEGAnet® system. Excluding MEGAspeed products, MEGAsystems' liability is only limited to the replacement and installation of equipment which does not fulfill the conditions in clauses 5 and 6 hereinabove. MEGAspeed products which do not fulfill the conditions of clause 5 will be repaired or replaced at MEGAsystems' discretion.

9. GOVERNING LAW

These conditions shall be governed by and construed in all respect in accordance with the law prevailing in the Republic of South Africa.
